Independent bids are invited for rights to ship U.S.-origin rice to the Republic of Colombia duty-free under a tariff-rate quota (TRQ) granted by the Republic of Colombia to the United States under the U.S.-Colombia Trade Promotion Agreement.

**between 9:00 a.m. and 5:00 p.m. Eastern Daylight Time (EDT)**

TRQ Certificates will be awarded to the highest bidder(s). Any person or entity incorporated or domiciled, with a legal address, in the United States is eligible to bid. Bid quantities should be submitted in metric ton, milled rice equivalent using the following conversion factors: rough rice (rice in hull) = 0.71; brown rice (hulled) = 0.89; broken rice = 1. The minimum bid price is \$30.00/metric ton. Bids must be submitted in dollars and cents per metric ton.

Each bidder must submit a performance security in the amount \$50,000 or the total value of the bid(s), whichever is less. Potential bidders may obtain the required bid forms and bid instructions from:
